What personal information does Pathways Data collect and receive?

Technologies

We and our partners, use cookies and similar technologies to analyze trends, administer the website, track users' movements around the website, and gather demographic information about our user base as a whole. Users can control the use of cookies at the individual browser level.

Log Files

We, and our third-party partners gather certain information automatically and store it in log files. This information includes the internet protocol (IP) address, browser type, internet service provider (ISP), and clickstream data. Why is Pathways Data collecting my personal information?

With whom does Pathways Data share my personal information?
